November 2021: GLOBAL MARKET INDEX PERFORMANCE



Global equities posted negative returns in November, with the MSCI ACWI IMI down -2.7%, the S&P 500 down -0.7%, and non-US developed equity markets down -4.7% in dollar terms. Growth stocks outperformed value stocks for the month, and large cap stocks outperformed small cap. U.S. investment-grade bonds increased 0.3% for the month while U.S. high yield was down -1.0%. Commodities decreased -7.3% and the all-items CPI was up by 0.9%.

For markets, November was dominated by rising Covid hospitalizations in parts of Europe and concerns about the new Omicron variant. On the policy front, Biden signed a long awaited \$550 billion bipartisan infrastructure bill in order to upgrade America's roads, bridges and railways and deploy electric vehicle charging stations across the country. In the emerging markets arena, while EM's economic backdrop improved over the last couple of weeks, EM equities and EM debt posted negative returns due to covid concerns.
